- a. The Primary Account Holder completes three years of service (36 continuous months) with excellent payment history determined by Huntsville Utilities Collection Activity¹, or
- b. An additional deposit is placed with Huntsville Utilities as established under Huntsville Utilities' current Residential Deposit Policy. At the time the additional deposit is made, all payments of the Primary Account Holder must be current, or
- c. If the Primary Account Holder owes any amount in Huntsville Utilities' bad debt account, currently or within the past seven (7) years, this agreement will remain in effect for the life of the account.

To qualify as a guarantor for another's account, the guarantor must a) currently have an active account with Huntsville Utilities, b) have had service for the last thirty-six consecutive months, and c) have an excellent payment history determined by Huntsville Utilities Collection Activity¹.

In the event the Guarantor's account 1) requires Collection Activity¹, or 2) is terminated with Huntsville Utilities during the term of this agreement, Huntsville Utilities reserves the right to require an additional deposit amount from the Primary Account Holder or services will be discontinued until such requirements are met. In addition, if the Guarantor's account closes for any reason, this will not relinquish the Guarantor's responsibility to pay any amount left unpaid by the Primary Account Holder.
